ORDER RE BRIEFING SCHEDULE
AND HEARING DATES

1 Direct Purchaser Plaintiffs (“Plaintiffs”) and Defendants Irico Display Devices Co., Ltd.
2 and Irico Group Corporation (together, “Irico”), by and through undersigned counsel, hereby
3 stipulate as follows:

4 WHEREAS, on August 14, 2017, Plaintiffs filed an Application For Default Judgment
5 By The Court Against The Irico Defendants (the “Default Judgment Application”) (MDL Dkt.
6 No. 5191);

7 WHEREAS, on October 25, 2017, Irico filed its Response to the Default Judgment
8 Application (MDL Dkt. No. 5214) and a Motion to Set Aside Default (MDL Dkt. No. 5215);

9 WHEREAS, the Motion to Set Aside Default is noticed for hearing on December 14,
10 2017, and the Default Judgment Application is set for hearing on December 7, 2017 (MDL Dkt.
11 No. 5213);

12 WHEREAS, Plaintiffs’ reply brief in support of the Default Judgment Application is due
13 November 8, 2017, and Plaintiffs’ opposition to the Motion to Set Aside Default is also due on
14 November 8, 2017;

15 WHEREAS, Plaintiffs request additional time to prepare the briefs due November 8 and
16 Irico requests a continuance of the December 7 hearing date based on counsel’s availability;

17 WHEREAS, the parties have met and conferred regarding the briefing and hearing
18 schedule for the Motion to Set Aside Default and the Default Judgment Application;

19 IT IS HEREBY STIPULATED AND AGREED by and between counsel for Irico and
20 Plaintiffs, that:

21 Plaintiffs’ reply brief in support of the Default Judgment Application and Plaintiffs’
22 opposition to the Motion to Set Aside Default shall be due on or before December 7, 2017;

23 Irico’s reply brief in support of the Motion to Set Aside Default shall be due on or before
24 December 21, 2017; and

25 The currently scheduled hearings on the Default Judgment Application and the Motion to
26 Set Aside Default shall be vacated. The parties have met and conferred and are available for
27 hearing on January 11, 2018, and February 1, 2018. The hearings shall be rescheduled for
28 January 11, 2018.
