**STIPULATION AND ~~[PROPOSED]~~ ORDER  
 EXTENDING DISCOVERY**

19 Despite the parties' efforts to complete discovery in accordance with the existing  
 20 schedule, the large breadth of issues to be addressed in the parties' litigation, and the substantial  
 21 volume of discovery remaining to be completed, lead the parties to conclude that an extension of  
 22 the fact discovery cutoff is necessary for the more orderly and efficient resolution of their  
 23 disputes. Consequently, the parties stipulate that the fact discovery deadline should be extended  
 24 from January 16, 2009 to April 24, 2009 and request that the Court enter an order to that effect.<sup>1</sup>

27 <sup>1</sup> This fact discovery cutoff is applicable only to the patents selected for the first stage of claim construction per the  
 28 parties' June 16, 2008 Joint Report on Claim Construction (Docket No. 79) and the Court's September 5, 2008 Order  
 Extending Discovery for Patents Not Selected for Claim Construction (Docket No. 142).

1 In light of the extension of the fact discovery deadline, the parties agree that the deadlines  
2 in the Court's October 7, 2008 Order Following Case Management Conference (Docket No. 174)  
3 should be modified as follows:

4 The deadline for opening expert reports should be extended from February 27, 2009 to  
5 June 5, 2009. The deadline for rebuttal expert reports should be extended from March 20, 2009  
6 to June 26, 2009. The close of expert discovery except on damages should be extended from  
7 April 10, 2009 to July 17, 2009. The deadline for filing final reply briefs of summary judgment  
8 motions should be extended from May 26, 2009 to September 1, 2009.

9 The parties also stipulate and jointly request that the Court move the hearing on summary  
10 judgment motions on NetApp's patents from June 18, 2009 to September 24, 2009, and the  
11 hearing on summary judgment motions on Sun's patents from June 25, 2009 to October 1, 2009.
