4 YOU ARE HEREBY NOTIFIED that pursuant to an Order of the United States District
5 Court for the Northern District of California, a hearing will be held on February 6, 2014, at 1:30
6 p.m., before the Honorable Edward M. Chen, United States District Judge, at the United States
7 District Court for the Northern District of California, 450 Golden Gate Avenue, Courtroom 5-17th
8 Floor, San Francisco, CA 94102, for the purpose of determining: (1) whether the proposed
9 settlement of the Litigation for the sum of \$95,000,000 in cash should be approved by the Court as
10 fair, reasonable, and adequate; (2) whether, thereafter, this Litigation should be dismissed with
11 prejudice against the Defendants as set forth in the Stipulation of Settlement dated as of August 8,
12 2013; (3) whether the Plan of Allocation of settlement proceeds is fair, reasonable, and adequate and
13 therefore should be approved; and (4) the reasonableness of the application of Lead Counsel for the
14 payment of attorneys’ fees and expenses incurred in connection with this Litigation, together with
15 interest thereon.

16 If you purchased VeriFone common stock or VeriFone put and call options between August
17 31, 2006 and April 1, 2008, inclusive, on any domestic or foreign exchange or otherwise, your rights
18 may be affected by this Litigation and the settlement thereof. If you have not received a detailed
19 Notice of Proposed Settlement of Class Action and a copy of the Proof of Claim and Release form,
