4 upon the following:

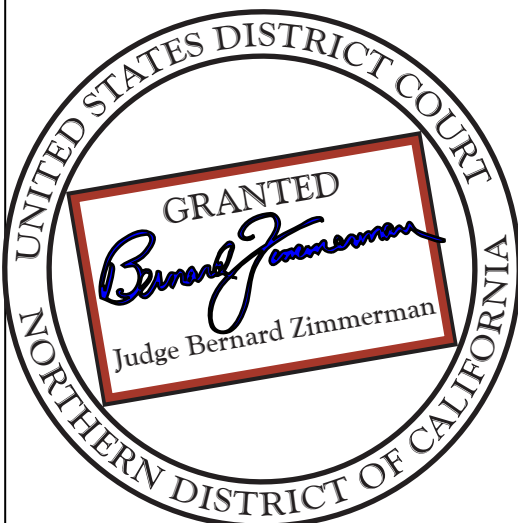
5 1. In an order dated November 12, 2008, the Court granted the
