18 WHEREAS, on October 3, 2008, the court re-referred the above-entitled action to mediation
 19 to be completed by December 2, 2008;

20 WHEREAS, the court further ordered that in the event the parties could not settle the case
 21 through mediation, to submit a status report (with plan of action and proposed deadlines) by
 22 December 12, 2008;

24 WHEREAS, the court further ordered that a further case management conference be held on
 25 Friday, December 19, 2008 at 1:30 p.m. in Courtroom 2 before the Hon. Jeffrey S. White;

26 WHEREAS, on October 29, 2008, Robin W. Siefkin, ADR Program Staff Attorney,
 27 informed the parties that she had been unable to reach Michael R. Sobel (the previous mediator

1 appointed by the court to mediate the case) to schedule a mediation session with Mr. Sobel before
2 the expiration of the deadline imposed by the court;

3 WHEREAS, Ms. Siefkin further informed the undersigned parties that it would be very
4 difficult, in view of the holiday season, to secure the services of another mediator and complete the
5 mediation by December 2, 2008;

7 Now, in light of the foregoing, plaintiff SPYROS ECONOMIDES and defendant PETER
8 TSAKANIKAS, who are all of the parties to this action, stipulate as follows:

- 9 1. The date to complete mediation is extended to January 30, 2009;
- 10 2. The status report (with plan of action and proposed deadlines) shall be due on
11 Monday, February 9, 2009; and
- 12 3. A further case management conference shall be held on Friday, February 20, 2009 or
13 any other date which is convenient to the court.
