21 THE PARTIES HEREBY STIPULATE, pursuant to Local Rules 6-1(b), 6-2, and 7-12,

- 24 1. On July 14, 2010, the parties informed the Court that they were actively engaged

3 2. On September 1, 2010, the parties entered into a Settlement Agreement in these  
4 consolidated cases. The Settlement Agreement provides that defendants shall  
5 make a payment to plaintiff EFF for attorneys' fees, expenses, and costs within 60  
6 days of the date of the Agreement and that the parties will jointly stipulate to  
7 dismiss these consolidated cases with prejudice.

8 3. Accordingly, there is no need for the Case Management Conference. A  
9 stipulation for dismissal will be filed after EFF receives its payment.
