1 WHEREAS, on November 6, 2009, the Court issued an Order on Motions to Dismiss
2 Second Amended Consolidated Class Action Complaint (“Second Amended Complaint”),
3 granting in part and denying in part Defendants’ motions to dismiss (the “Order”) (Docket No.
4 144);

5 WHEREAS, pursuant to Fed. R. Civ. P. 12(a)(4)(A), the remaining Defendants would be
6 required to answer the Second Amended Complaint on or before November 23, 2009;

7 WHEREAS, the Order provided that “[i]f Plaintiffs choose to file an amended complaint
8 on the terms set forth in this Order, they must do so by no later than November 25, 2009”;

9 WHEREAS, Plaintiffs have not yet determined whether they will file a Third Amended
10 Complaint on or before November 25, 2009;

11 WHEREAS, Defendants have met and conferred with Plaintiffs and requested a 30-day
12 extension of the time for all Defendants required to answer the Second Amended Complaint (from
13 November 23, 2009 through and including December 23, 2009) to answer it, and requested that if
14 a Third Amended Complaint is filed on or before November 25, 2009, that all Defendants required
15 to respond to it have a total of 45 days (through and including January 11, 2010) to move against,
16 answer or respond to a Third Amended Complaint; and

17 WHEREAS, Plaintiffs have consented to Defendants’ request;

18 IT IS HEREBY STIPULATED, by and between Plaintiffs and Defendants, through their
19 respective counsel, and subject to Court approval, that the time for all Defendants required to
20 answer the Second Amended Complaint shall be extended for 30 days (from November 23, 2009
21 through and including December 23, 2009), and that if a Third Amended Complaint is filed on or
22 before November 25, 2009, that all Defendants required to respond to the Third Amended
23 Complaint shall have a total of 45 days (through and including January 11, 2010) to move against,
24 answer or respond to the Third Amended Complaint.


