18 Plaintiffs and Defendants, by and through their respective undersigned counsel, stipulate  
19 and agree as follows:

20 WHEREAS, by Clerk's Notice dated July 2, 2010, the Court set a Case Management  
21 Conference in this matter for September 3, 2010, at 1:30 p.m., in Courtroom 11 before the  
22 Honorable Jeffrey S. White (Docket No. 163);

23 WHEREAS, by stipulation and order dated July 17, 2010, the Case Management  
24 Conference date in this matter is presently set for September 10, 2010, at 1:30 p.m. in Courtroom  
25 11 before Judge White (Docket No. 167);

1 WHEREAS, Defendants subsequently chose Kenneth Lapatine, a shareholder in Greenberg  
2 Traurig, LLP, attorneys for the First American Title Insurance defendants, to be lead counsel for all  
3 Defendants at the Case Management Conference.

4 WHEREAS, Mr. Lapatine is an observant member of the Jewish faith.

5 WHEREAS, the second day of Rosh Hashanah, one of the high holidays for members of  
6 the Jewish faith, falls on Friday, September 10, 2010.

7 WHEREAS, Yom Kippur, one of the high holidays for members of the Jewish faith, begins  
8 on Friday, September 17, 2010.

9 WHEREAS, Plaintiffs and Defendants understand that Judge White's Civil Standing  
10 Orders call for Case Management Conferences to be conducted on Fridays.

11 WHEREAS, to accommodate Mr. Lapatine's religious beliefs, Defendants respectfully  
12 request, and Plaintiffs do not oppose, that the date for the Case Management Conference be  
13 specially set on September 7 or 8, or another subsequent date convenient with the Court, subject to  
14 Court approval;

15 WHEREAS, the parties agree that should the Court decline to alter the date of the Case  
16 Management Conference, that Mr. Lapatine be permitted to attend the September 10, 2010 Case  
17 Management Conference telephonically; and,

18 WHEREAS, Plaintiffs and Defendants agree to adhere to the Clerk's Notice in all other  
19 respects, and will submit a joint Case Management Conference statement on or before five court  
20 days before the rescheduled Case Management Conference Date; and

21 IT IS HEREBY STIPULATED, by and between Plaintiffs and Defendants, through their  
22 respective undersigned counsel, and subject to Court approval, that the date for the Case  
23 Management Conference be rescheduled from September 10, 2010 to September 7 or 8, or another  
24 subsequent date convenient with the Court; in the alternative, it is hereby stipulated by and between  
25 Plaintiffs and Defendants, through their respective undersigned counsel, and subject to Court  
26 approval, that Mr. Lapatine be permitted to telephonically attend the September 10, 2010 Case  
27 Management Conference.


