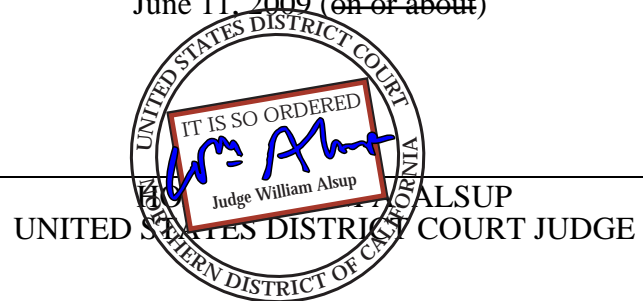
1 This matter comes before the Court on Lead Plaintiffs' Stipulated Motion to Change the
