EX PARTE APPLICATION TO CONTINUE CASE MANAGEMENT CONFERENCE AND EXTEND TIME TO
SERVE DEFENDANT AND [PROPOSED] ORDER

1 Plaintiffs respectfully request that the Court continue the case management conference
2 currently set for October 10, 2008, at 10:30 a.m. to January 9, 2009. Plaintiffs further request,
3 pursuant to the Federal Rules of Civil Procedure, Rules 4(m) and 6(b)(1)(A), that the Court grant an
4 additional 60 days – until December 23, 2008 – to serve Defendant with the Summons and Amended
5 Complaint. As further explained below, Plaintiffs recently filed an Amended Complaint naming Mr.
6 Rodriguez but service has not yet been effectuated. In support of their request, Plaintiffs state as
7 follows:

8 1. The initial case management conference is currently scheduled for October 10, 2008,
9 at 10:30 a.m. The current deadline for service of process is September 23, 2008 having been
10 extended once when defendant was a Doe Defendant. No previous continuances or extensions have
11 been requested or granted in this case.

12 2. Plaintiffs filed their Complaint for Copyright Infringement against Defendant John
13 Doe (“Defendant”) on March 27, 2008. Plaintiffs did not have sufficient identifying information to
14 name Defendant in the Complaint, but were able to identify Defendant by the Internet Protocol
15 address assigned by Defendant’s Internet Service Provider (“ISP”) California State University
16 Monterrey Bay. Accordingly, in order to determine Defendant’s true name and identity, Plaintiffs
17 filed their Application for Leave to Take Immediate Discovery on March 27, 2008, requesting that
18 the Court enter an Order allowing Plaintiffs to serve a Rule 45 subpoena on the ISP.

19 3. The Court entered an Order for Leave to take Immediate Discovery which was
20 promptly served upon the ISP along with a Rule 45 subpoena. On June 11, 2008 the ISP identified
21 the infringer as Christopher Rodriguez. Thereafter, Plaintiffs sent a letter to Mr. Rodriguez formally
22 notifying him of their claim and requesting that he contact Plaintiffs.

23 4. Settlement negotiations did not prove fruitful and on August 26, 2008, Plaintiffs filed
24 an amended complaint naming Mr. Rodriguez individually. Plaintiffs promptly engaged the services
25 of a process server but to date service has not been effectuated.

26 5. Given the foregoing circumstances, Plaintiffs respectfully request that the case
27 management conference be continued to January 9, 2009, or such other date as conveniences the
28 Court.


1 **[PROPOSED] ORDER**

2 Good cause having been shown:

3 **IT IS ORDERED** that the case management conference currently set for October 10, 2008,
4 at 10:30 a.m. be continued to January 9, 2009.

5 **IT IS FURTHER ORDERED** that, pursuant to the Federal Rules of Civil Procedure, Rules
6 4(m) and 6(b)(1), Plaintiffs' time to serve the Summons and Complaint on Defendant be extended
7 for 60 days, to December 23, 2008.
