**STIPULATION FOR ENTRY OF
ORDER OF DISMISSAL AND
[PROPOSED] ORDER**

WHEREAS certain parties to this action, namely, Plaintiff, ONITA TUGGLES and
defendants HOUSING AUTHORITY OF THE COUNTY OF CONTRA COSTA, ELIZABETH
CAMPBELL, KATHY GUZMAN and JOANNA RODRIGUEZ (the "Settling Parties"), have
reached a mutual and amicable settlement and have entered into separate agreements for
settlement of claims between them in this action, the terms of which are set forth in writing in the
Settlement Agreement and General Release and the Agreement Between Plaintiff Onita Tuggles
and Housing Authority of Contra Costa County Defendants to Preserve and Protect the
Confidentiality of Juvenile Court and Juvenile Police Records, to fully and finally resolve all
matters relating to the Settling Parties in this action without trial;

1 WHEREAS the Settlement Agreements cover all the claims between the Settling Parties
2 in this action;

3 WHEREAS the Settling Parties agree to pay their own attorney's fees and costs;

4 WHEREAS there are no further issues between the Settling Parties for the Court to
5 resolve; and


6 WHEREAS the Settling Parties have agreed that the Court should retain jurisdiction for
7 the purpose of enforcing the terms of the Settlement Agreement,

8 NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED AS FOLLOWS:


- 9 1. Plaintiff's action defendants HOUSING AUTHORITY OF THE COUNTY OF
10 CONTRA COSTA, ELIZABETH CAMPBELL, KATHY GUZMAN and
11 JOANNA RODRIGUEZ, including references to said parties in each of Plaintiff's
12 causes of action set out in Plaintiff's Complaint, shall be dismissed with
13 prejudice, with each party to bear her/its own attorney's fees and costs.
- 14 2. The Court shall retain jurisdiction to enforce the terms of the Settling Parties'
15 Settlement Agreements.
