 22 The plaintiff, by and through his attorney of record, and defendants, by and through their
 23 attorneys of record, hereby stipulate, subject to approval of the Court, to a 60-day extension of the
 24 parties' cross-motions for summary judgment. The parties agree that there is a reasonable
 25 likelihood that this case can be administratively resolved in the next 60 days, and that the case will
 26 be moot.

27 Accordingly, the parties respectfully ask this Court to extend the date of the parties' cross-
 28 motions for summary judgment by 60 days, and vacate the hearing scheduled for October 29, 2008.
