15 simultaneously with the close of escrow contemplated by the pending  
16 settlement hereunder, and that any such disputes will be resolved by

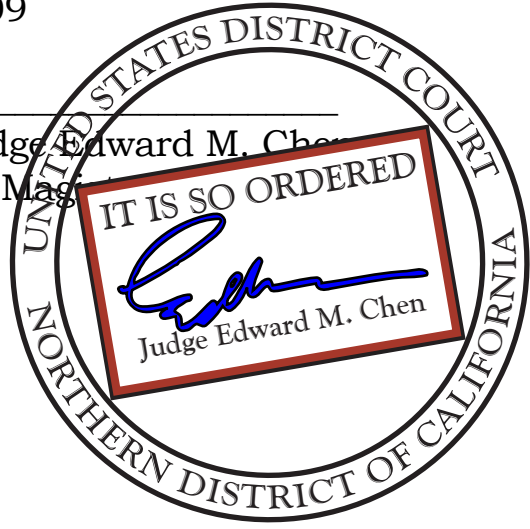
