11	it will be reasonably possible for her to complete the discovery necessary for her class		
12	certification motion within the next 3 weeks; and		
13	WHEREAS, plaintiff will also seek leave to amend her Complaint to allege new legal		
14	theories against SMC and SMC reserves its right to oppose any amendment to the Complaint;

25	2. Plaintiff shall file either (a) her proposed First Amended Complaint along with a		
26	Stipulation with SMC agreeing to the filing or (b) a motion for leave to file her proposed First
