21 IT IS HEREBY STIPULATED by and between plaintiff United States of America and claimant
22 Todd Dunphy, through undersigned counsel, that this action be stayed pursuant to 18 U.S.C. § 981(g) and
23 21 U.S.C. § 881(i).


24 Claimant Todd Dunphy is currently the subject of a related criminal investigation in Hawaii. The
25 allegations in the forfeiture complaint are based, in large part, on the allegations at issue in the related
26 criminal investigation. Both parties have talked to the U.S. Attorney's Office in Hawaii, and understand
27 that the related criminal case will be indicted in the next 60 days. Consequently, the parties agree that a
28 stay in the forfeiture proceeding for 60 days is appropriate in order for the parties to evaluate

1 the issues to be raised in the pending indictment and to determine how that criminal proceeding will affect
2 the present case.


