2 of the following Order regarding page limits applicable under the Local Rules in connection with  
3 the parties' class certification briefing:

4 WHEREAS, pursuant to the Court's September 9, 2009 order<sup>1</sup>, Plaintiffs' motion in support  
5 of class certification is currently due November 9, 2009, Defendant's opposition to Plaintiffs' class  
6 certification motion is currently due January 28, 2010, and Plaintiffs' reply in support of class  
7 certification is currently due on February 26, 2010;

8 WHEREAS, pursuant to Local Rules 7-2(b), 7-3(a), 7-3(c), and 7-4(b) concerning page  
9 limitations, a motion and an opposition to a motion may not exceed 25 pages in length and the  
10 reply to the opposition may not exceed 15 pages of text;

11 WHEREAS, given the nature of the class certification briefing, the parties hereby seek an  
12 extension to the page limits;

16 40 pages in length;

17 2. Defendant's memorandum in opposition to Plaintiffs' motion for class certification shall  
18 not exceed 40 pages in length; and

19 3. Plaintiffs' reply memorandum in support of motion for class certification shall not  
20 exceed 25 pages in length.
