On April 9, 18 2012, the stay was lifted and Respondent was ordered to show cause why the amended 19 petition should not be granted. On April 18, 2012, Petitioner filed a "notice of 20 abandonment" and accompanying declaration. These documents were signed by Petitioner 21 on May 27, 2010, and Petitioner had previously filed them in this case in July 2010. As a 22 result, this document appears to have been filed in error.
