20 IT IS HEREBY STIPULATED by and between Plaintiff, Kevin E. Chambers  
 21 (“Plaintiff”), and Defendant, International Fidelity Insurance Company (“Defendant”), through  
 22 their respective attorneys of record herein, as follows:

- 23 1. The Court set an Order to Show Cause hearing for Monday, November 24, 2008,


