19 continuance of the hearing and discovery dates in this case.

20 In order to accommodate the schedule of plaintiff's counsel, the parties stipulate as  
21 follows:

22 The last day for the summary judgment hearing date previously scheduled for November  
23 2, 2009 will be continued to **December 14, 2009**.

24 Defendant's last day for filing her summary judgment motion is extended to **November**  
25 **9, 2009**.

26 This Court previously limited discovery to four depositions per side. The Court allowed  
27 defendant two hours to complete plaintiff's deposition. These depositions will be completed no  
28 later than **October 30, 2009**.
