**STIPULATION FOR ORDER
 CONTINUING CASE MANAGEMENT

 21 Plaintiffs, by and through their counsel, Defendant Cottman Transmission Systems, LLC
 22 (“Cottman”), by and through its counsel, and Specially Appearing Defendant American Driveline
 23 Systems, Inc. (“ADS”), by and through its counsel, hereby stipulate as follows:

24 1. This case is now set for a Case Management Conference on December 19, 2008 at 2:00
 25 p.m.

26 2. On November 7, 2008, the Court heard a motion to compel arbitration by Cottman,
 27 and a motion pursuant to FRCP 12(b)(2) by ADS. The Court provided a tentative ruling during
 28 the hearing on November 7, but the Court has not yet issued a final ruling.

1 3. In light of the fact that the Court's rulings on the pending motions could obviate a Case
2 Management Conference and the setting of a trial date and pretrial dates, or otherwise change
3 issues to be addressed, the parties hereby stipulate, as follows:

4 (a) That the currently set November 21, 2008 Case Management Conference be
5 continued to January 30, 2009 at 2:00 p.m.,


6 (b) That the deadline for the parties' submission of a Joint Case Management
7 Conference Statement be continued to January 23, 2009; and

8 (c) That the parties' exchange of initial disclosures under Federal Rule of Civil
9 Procedure 26 be continued to January 23, 2009.
