18 WHEREAS, Plaintiff and Defendant have reached an agreement in principle and are
 19 working to draft and execute a settlement agreement and need more time in which to complete
 20 this process:

21 IT IS HEREBY STIPULATED by Plaintiff and Defendant (by their counsel) that,

- 22 1. Plaintiff and Defendant, hereby agree that Defendant Command Audio
 23 Corporation has until and including February 6, 2009 to answer, move or otherwise respond to the
 24 Complaint.
- 25 2. Plaintiff and Defendant also agree that the times in which the parties have to:
 - 26 a. Meet and confer regarding: initial disclosures, early settlement, ADR
 27 process selection, and a discovery plan;
 - 28 b. File an ADR Certification signed by Parties and Counsel; and

1 c. File either a "Stipulation to ADR Process" or a "Notice of Need for ADR
2 Phone Conference"

3 are hereby extended to and including January 30, 2009.

4 3. The parties also request that the Case Management Conference, currently set for
5 January 16, 2009, be extended to any date that is convenient for this Court on or after
6 February 18, 2009.
