24 with the parties;" and


25 WHEREAS, Michael E. Stone, lead counsel for Plaintiffs, BRENDA HICKMAN and BETTY

27 United States until September 30, 2008;


28 NOW, THEREFORE, IT IS HEREBY STIPULATED by and between counsel for Plaintiffs,
