28 2010;



3 bond pending appeal should be rescheduled to July 23, 2010.



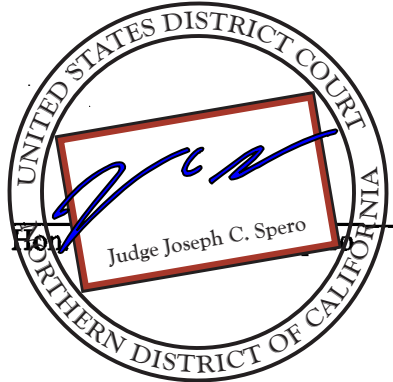
