) **ORDER TO CONTINUE INITIAL CASE**
) **MANAGEMENT CONFERENCE**

1 It is hereby stipulated by and between the parties to this action, plaintiff Donnie Cox, and
2 his attorneys, and defendant Electronic Data Systems Corporation, and its attorneys, as follows:

3 1. On August 18, 2008, this Court issued its order setting initial case management
4 conference and ADR deadlines. Said order set the initial case management conference for
5 December 4, 2008 at 11:00 a.m.

6 2. On September 2, 2008, plaintiff moved to continue the initial case management
7 conference on grounds his counsel had a trial in San Luis Obispo county on the same date.

8 3. On September 12, 2008, this court denied said motion subject to a new motion
9 brought closer to the trial date.

10 4. Plaintiff Cox's counsel are the counsel of record in *Susan Bradford and Lavona*
11 *Stanley v. Dirk Winter, et al.*, case no. CV070354, venued in the San Luis Obispo County
12 Superior Court.

13 5. During a January 31, 2008 case management conference, the jury trial for case no.
14 CV070354 was set to begin on December 1, 2008. Said trial is expected to take approximately
15 two weeks to complete.

16 6. As of the date of this stipulation, the trial for case no. CV070354 is still set to begin
17 on December 1, 2008.

18 7. Based on the foregoing, the parties request that the initial case management
19 conference in this matter be continued to January 8, 2009 at 11:00 a.m.
