1 Pursuant to Local Rules 6-2 and 7-12, Plaintiff CITY OF STOCKTON ("Plaintiff")
2 and Defendant UBS AG, on behalf of itself and all defendants to this action (collectively
3 "Defendants"), hereby stipulate that Defendants' time to respond to the Complaint is
4 extended up to and including December 15, 2008. The parties further stipulate that, with
5 the approval of the Court, the Case Management Conference set by this Court for December
6 5, 2008 shall take place on January 30, 2009, or as soon thereafter as may be practicable.
7 The parties' joint case management statement shall be submitted not less than seven days
8 before the conference.


9 As set forth in the attached Declaration of Scott A. Westrich, the parties request these
10 extensions to place Defendants' responses on a common schedule with a related action and
11 to allow Defendants sufficient time to respond given the complexity of the allegations.
12 Defendants removed a similar action, *County of San Diego v. Bank of America, N.A., et al.*,
13 No. CV 08-06283 FMC (C.D. Cal.), on September 24, 2008. The parties have stipulated
14 that responses in that action must be filed on or before December 15, 2008. The requested
15 extension postpones proceedings in this case by less than 60 days. Only one prior time
16 modification has been requested.

17 This stipulation is made without prejudice to any defense of Defendant UBS AG or
18 any other defendant.
