**ORDER COMPELLING THE
ATTENDANCE OF ANTONIO
ZAMORA AT DEPOSITION**

On May 20, 2009, Plaintiffs' Motion for and Order of
Contempt and to Compel the Attendance at Deposition of Antonio
Zamora came regularly on for hearing. Julie M. Houk
appeared telephonically on behalf of the Plaintiffs. No
appearance was made by Defendants. Antonio Zamora, who had

1 been subpoenaed to attend the hearing, failed to appear.
2 Having reviewed the moving papers filed by Plaintiffs, in the
3 absence of any opposition to the motion, and for good cause
4 shown,

5 **IT IS HEREBY ORDERED** that Antonio Zamora shall appear for
6 his deposition on **Thursday, August 27, 2009, at 10:00 a.m.**

7 Said deposition shall be taken in Courtroom G, 15th Floor of
8 the United States District Court for the Northern District of
9 California, which is located at 450 Golden Gate Avenue, San
10 Francisco, California.

11 Mr. Zamora shall answer all questions put to him at the
12 time of the deposition relevant to the subject matter of this
13 litigation and/or reasonably calculated to lead to the
14 discovery of relevant evidence unless said questions would
15 call for information legitimately protected by the attorney-
16 client privilege or other legitimate privilege.


17 In the event that the case is finally settled prior to
18 August 27, 2009, Plaintiffs shall provide Mr. Zamora with
19 written notice of said settlement. However, in the absence of
20 any written notice from Plaintiffs' counsel, Mr. Zamora is
21 required to attend and appear for his deposition on August 27,
22 2009.

23 **IT IS HEREBY FURTHER ORDERED** that in the event that
24 Antonio Zamora fails or refuses to attend said deposition
25 and/or fails to answer questions at the time of his deposition
26 without legal justification, the Court will certify the facts
27 of his contempt of the Court's Order to the Honorable William
28 H. Alsup. Mr. Zamora is hereby admonished that his failure to

1 appear for the deposition on **August 27, 2009, at 10:00 a.m.** as
2 set forth above, may result in him being held in contempt of
3 Court and he could be subjected to a variety of sanctions,
4 including, but not limited to, arrest, monetary sanctions
5 and/or other sanctions as may be deemed appropriate by this
6 Court.

7 Plaintiffs shall serve a copy of this Order on Mr.
8 Zamora.
