1 In accordance with Local Rule 7-2 and this Court's order of December 18, 2008 (D.E.  
2 34), Plaintiff ThinkVillage-Kiwi, LLC ("TVK") and Defendants Adobe Systems, Inc. and Adobe  
3 Macromedia Software LLC (collectively "Adobe") respectfully request miscellaneous  
4 administrative relief resetting the Case Management Conference currently scheduled for May 1,  
5 2009 to June 5, 2009.

6 The Court scheduled the Case Management Schedule for May 1, 2009 based on its order  
7 of December 18, 2008 directing the parties to participate in a private mediation in the last half of  
8 March or early April (D.E. 34). On January 9, 2009, the Court granted the parties stipulated
