This Stipulation is entered into by Plaintiffs WILLIAM and VERONICA FORD

18 (“Plaintiffs”) and Defendants WELLS FARGO HOME MORTGAGE, a division of WELLS

19 FARGO BANK, N.A. (collectively “Wells Fargo”).

20 A status conference is scheduled for January 23, 2009 at 10:00 a.m. The parties hereby

21 stipulate to a continuance to March 20, 2009, at 10:00 a.m. in Courtroom 1 as the case has settled
