22 This action having come before the court and the court
23 having considered the same and, on November 5, 2009, ordered entry
24 of judgment in favor of plaintiffs, (Doc # 41) now therefore:

26 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:
27

28 Plaintiff is entitled to judgment against, jointly and
severally, Architectural Metal Products, Inc, Pacific
Rollforming, LLC, Ridgetop Hawaii, Inc, Ridgetop Roofing and
Gutter, Inc, Boris Gokhman, Vladimir Shuk and Todd Beasley
(collectively "served defendants") as of August 5, 2008 in the

1 amount of \$475,417.68, together with per diem interest in the
2 amount of \$300.80, attorney fees as of March 25, 2009 in the
3 amount of \$33,134.53, rent charges in the amount of \$3,500.00
4 and post-judgment interest from the date hereof.

6 IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that:

8 With respect to Architectural Metal Products, Inc, plaintiff is
9 entitled to have its security interest in the following
10 collateral foreclosed, to have a sale directed and to have the
11 proceeds apply to satisfy the debt owing to plaintiff from
12 defendants. Architectural Metal Products, Inc is further
13 directed to turn over the collateral to plaintiff at such place
14 or places as plaintiff chooses within ten (10) days hereof.
