1 Plaintiffs and counterclaim defendants RealNetworks, Inc. and RealNetworks Home
2 Entertainment, Inc. (collectively, “RealNetworks”) hereby certify that they have complied in all
3 respects with the Court’s June 18, 2009 Stipulated Preservation Order. In particular,
4 RealNetworks has, itself or through its attorneys:

- 5 1. Confirmed that it is “preserv[ing] all extant and future documents, data or tangible things
6 relating to all products or other matters at issue in this litigation, including
7 RealDVD, Vegas and/or Facet (the ‘Materials’);”
- 8 2. Confirmed that, with the exception of “backup tapes created for disaster recovery purposes
9 and maintained on a temporary basis,” the Materials are not, and are not stored on media
10 that is, subject to “routine destruction recycling, relocation, or mutation”; and
- 11 3. Directed actual and potential custodians to maintain the Materials indefinitely.
