3 Plaintiff's Motion Is Granted.


4 Judgment shall be entered in favor of Plaintiff Stevenson Enterprises and against

6 Plaintiff is awarded a total of ~~\$466,683.34~~ consisting of ~~\$395,098.46~~ costs and
7 expenses incurred in the investigation and remediation of the VOC impaction caused by
8 Defendant Hak Chon Lee. Plaintiff is further awarded as damages ~~\$143,206.75~~ attorneys fees
9 and costs. \$121,281.96
