STIPULATION TO ENLARGE TIME
 TO ANSWER OR RESPOND TO
 COMPLAINT

20 WHEREAS, on October 29, 2008, Plaintiff Changhui Hu filed a complaint in this Court
 21 naming as defendants Cadence Design Systems, Inc. (“Cadence”), Michael J. Fister, William Porter,
 22 and Kevin S. Palatnik (together “Defendants”);

23 WHEREAS, another complaint has been filed against Cadence and certain of the additional
 24 defendants in this Court containing similar allegations;

25 WHEREAS, to conserve the resources of the parties and the Court, the parties have agreed
 26 that Defendants need not answer or otherwise respond to the actions filed against Defendants until
 27 after a lead plaintiff is selected and a consolidated amended complaint is filed and served on
 28 Defendants.

NOW THEREFORE, IT IS HEREBY STIPULATED, pursuant to Civil L.R. 6-1(a), by and
 between Plaintiff and Defendants that the time by which Defendants must answer or otherwise
 respond in the above-captioned action is extended until after the Court’s order selecting a lead

1 plaintiff and the filing of a consolidated amended complaint in this action. In the event that Plaintiff
 2 Hu is determined to be lead plaintiff, Defendants will have 45 days after the filing of the consolidated
 3 amended complaint to file their response. Plaintiff will have 45 days after the filing of the response
 4 to file any opposition, and Defendants will have 30 days in which to file any reply.




