1 **STIPULATION**

2 WHEREAS, on June 9, 2010, the Court entered an order scheduling a case  
3 management conference on October 4, 2010 for control purposes, and ordered the  
4 parties to advise the Court in a stipulated request to continue the case management  
5 conference for not more than 120 days if the FCC matter has yet to be resolved by  
6 that date;

18 that date, in which case the parties will contact the Court within two weeks of the  
19 FCC’s ruling and request a case management conference with this Court within the  
20 earliest reasonable time frame.
