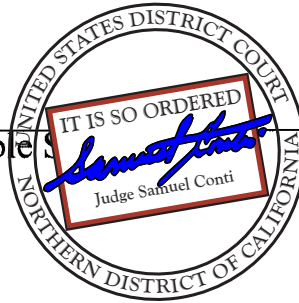
Having considered the parties' Stipulation to Dismiss Entire Civil Action with Prejudice, IT IS HEREBY ORDERED that:
