3 to the following facts:

4 **RECITALS**

5 A. Due to a medical emergency, on August 10, 2010, lead counsel for
6 Vector, John P. Zaires, was admitted to a local hospital for examination and testing,
7 making him unavailable for the case status conference and hearing on Vector's motion
8 to strike Plaintiff's third amended complaint and Plaintiff's motion to quash, all of
9 which were set for August 11, 2010.

10 B. For the convenience of Vector, plaintiff has agreed to a brief continuance
11 of the noticed motions and case status conference from August 11, 2010 to the Court's
