On April 9, 2009 the Court conducted an order to show case hearing regarding Plaintiff Mathew Harney's failure to comply with court orders and provide defendants' addresses for service. Based on discussions at the hearing, the Court granted Plaintiff a second opportunity to comply and ordered him to provide the Clerk of Court with the current address for each defendant named in his complaint by April 16, 2009.
