2 (“Defendants”) (collectively, “the parties”) hereby submit this Stipulation and [Proposed] Order to
3 Continue the telephonic status conference currently scheduled for December 4, 2012.

4 **STIPULATION**

5 WHEREAS, on October 17, 2012, the Parties conducted a Settlement Conference before
6 Magistrate Judge Vadas, at which the Parties reached a tentative settlement of this lawsuit;

7 WHEREAS, counsel for the Parties have worked since the Settlement Conference to reach
8 final terms for the settlement agreement, but have not yet agreed on final terms;

9 WHEREAS, Plaintiff’s counsel’s offices are in San Francisco, California, and Plaintiff is
10 incarcerated in the Segregated Housing Unit at Corcoran State Prison, a round trip distance of
11 approximately 500-miles;

12 WHEREAS, Plaintiff’s counsel’s communication with Plaintiff for the purpose of discussing
13 and approving settlement terms has been limited to US mail, which is delayed by the prison security
14 screening system;

15 WHEREAS, the Parties agree that the December 4, 2012 Case Management Conference
16 should be continued in the interests of judicial economy due to the near final resolution of this
17 matter;

18 IT IS HEREBY STIPULATED, by and between the parties that the December 4, 2012
19 telephonic status conference should be continued due to the pending settlement discussions until
20 December 18, 2012.

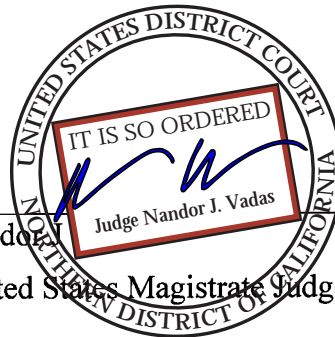
ORDER
