18	discussions prior to filing dispositive motions;				
19	WHEREAS, neither party has been or will be prejudiced by the continuation of these				
20	litigation deadlines;				
21	WHEREAS, the Parties' stipulation does not affect the trial date or date for pre-trial				
22	conference;
