1 This matter is before the court on the parties Joint Motion for Extension of
2 Pre-Trial Deadlines. The parties jointly support the instant motion. The Court has
3 reviewed the motion and pleadings and papers filed in the instant action and finds
4 that there is good cause to grant the motion.

5 IT IS HEREBY ORDERED that the Joint Motion for Extension of Pre-Trial
6 Deadlines is hereby GRANTED.

7 IT IS FURTHER ORDERED that:

- 8 1. Deadlines in the instant action are hereby set as follows:
 - 9 a. Amendment of Complaint – March 15, 2010;
 - 10 b. Plaintiff’s Motion for Class Certification - May ²⁸~~30~~, 2010;
 - 11 c. Hearing on Motion for Class Certification - July ¹⁶~~13~~, 2010; and
 - 12 d. Case Management Conference - August ²⁷~~11~~, 2010; a Joint Case
13 Management Statement shall be filed no later than August 20, 2010.
- 14 2. Defendant shall produce one or more Rule 30(b)(6) representatives to
15 testify concerning the subject matters of ascertainability and numerosity of the
16 Classes, by April 30, 2010.
- 17 3. Plaintiffs shall file any fourth amended complaint on or before March
18 15, 2010.
