4 that date pending approval of this stipulation by the Court.





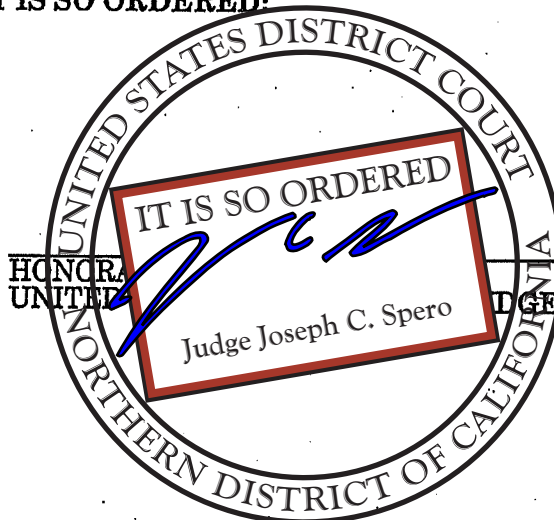
