17 WHEREAS, on September 25, 2009, Defendants filed a motion for summary judgment;
 18 and
 19 WHEREAS, Defendants' motion is currently set for hearing on April 2, 2010, with
 20 Plaintiff's opposition papers due by March 12; and
 21 WHEREAS, Plaintiff has, with the Court's permission, initiated discovery relevant to his
 22 opposition to Defendants' motion; and
 23 WHEREAS, the parties have a discovery dispute which has been scheduled for a hearing
 24 before Magistrate Laporte on March 23, 2010; and

1 WHEREAS, the parties cannot resolve the pending discovery dispute before the
2 Plaintiff's opposition to Defendants' summary judgment motion is due;

3 NOW, therefore, the parties stipulate and agree that the hearing date on Defendants'
4 motion for summary judgment shall be continued to May 28, 2010. Plaintiff's Opposition to
5 Defendants' Motion for Judgment will be filed no later than May 7 (21 days before the new
6 hearing date), and Defendants' Reply Brief shall be filed no later than May 14 (14 days before
7 the hearing).
