 22 Pursuant to stipulation by and between the parties hereto, plaintiff Trace-Wilco, Inc.
 23 and defendants Symantec Corporation (“Symantec”), Cisco Systems, Inc. (“Cisco”),
 24 McAfee, Inc. (“McAfee”) and Google, Inc. (“Google”), through their respective attorneys of
 25 record, hereby request that the Initial Case Management Conference now scheduled for May
 26 15, 2009 be rescheduled to June 19, 2009, subject to the Court’s schedule and availability.

2 WHEREAS, there has been one previous extension, from April 3, 2009, to May
3 15, 2009.

4 WHEREAS, subsequent to the first motion for extension, plaintiff on March 30,
5 2009 filed an unopposed motion to file a first amended complaint, adding as defendants
6 Cisco, McAfee and Google. All three defendants, when served with the First Amended
7 Complaint, requested and received extensions of time in which to answer, to May 22,
8 2009. Thus, as a result of these extensions, the three new defendants will not have
9 answered until after the current date for the Case Management Conference, May 15. One
10 of the new defendants, McAfee, does not yet have litigation counsel for this matter.

12 Accordingly, in order to provide the newly-added defendants time to prepare for
13 and fully participate in the Case Management Conference, the parties hereby
14 STIPULATE that the date for the Case Management Conference be rescheduled for June
15 19, 2009, or as soon thereafter as is convenient for the Court.


