20 **ORDER AND WRIT OF HABEAS
 21 CORPUS AD TESTIFICANDUM TO
 22 TRANSPORT INMATE- PLAINTIFF
 23 JAMES ALLEN BUSH (DWF967-

25 Inmate-Plaintiff James Allen Bush (DWF967-08086698), who is representing
 26 himself in the above-entitled action, is a necessary and material witness to the settlement
 27 conference scheduled to take place before the Honorable Nandor J. Vadas at **9:00 a.m.**
 28 **on January 31, 2011 in Courtroom D on the 15th Floor of 450 Golden Gate Avenue,
 San Francisco, CA 94102.**

Inmate Bush is currently confined at the Santa Clara County Main Jail, in San Jose,
 California, in the custody of the Warden. To secure Inmate Bush's attendance at this
 settlement conference, it is necessary that a Writ of Habeas Corpus Ad Testificandum
 issue commanding Inmate Bush's custodian to produce him at the abovementioned time
 and place, until the completion of this proceeding or as ordered by the Court, and
 thereafter to return Inmate Bush to the Santa Clara County Main Jail.

1 ACCORDINGLY, IT IS ORDERED THAT:

2 1. A Writ of Habeas Corpus ad Testificandum issue, under the seal of this
3 Court, commanding the Warden of the Santa Clara County Main Jail and the California
4 Department of Corrections and Rehabilitation to produce Inmate James Allen Bush
5 (DWF967-08086698) for a settlement conference at 9:00 a.m. on January 31, 2011 in
6 Courtroom D on the 15th Floor of 450 Golden Gate Avenue, San Francisco, CA 94102,
7 until the completion of this proceeding or as otherwise ordered by the Court, and thereafter
8 to return Inmate Bush to the Santa Clara County Main Jail.

9 2. The custodian is further ordered to notify the Court of any change in the
10 custody of Inmate Bush and is ordered to provide the new custodian with a copy of this writ.

11 **WRIT OF HABEAS CORPUS AD TESTIFICANDUM**

12 **To: The Warden of the Santa Clara County Main Jail:**

13 YOU ARE COMMANDED to produce Inmate James Allen Bush (DWF967-
14 08086698), for a settlement conference on at 9:00 a.m. on January 31, 2011 in Courtroom
15 D on the 15th Floor of 450 Golden Gate Avenue, San Francisco, CA 94102, until the
16 completion of this proceeding or as otherwise ordered by the Court, and thereafter to
17 return Inmate Bush to the Santa Clara County Main Jail.

18 FURTHER, you have been ordered to notify the Court of any change in the custody
19 of Inmate Bush, and have been ordered to provide a copy of this order to any new
20 custodian.
