**STIPULATED REQUEST FOR ORDER
 CHANGING TIME FOR CASE
 MANAGEMENT CONFERENCE
 SCHEDULED FOR APRIL 20, 2012
 ORDER THEREON**

Action Filed: March 10, 2009

1 Pursuant to Civil L.R. 6-2, Plaintiff Young and Defendants Holmes, Bullock, Buchanan,
2 Kiplinger, Kingstrom, Northrup, and Shellabarger (“Parties”), by and through their respective
3 counsel of record, hereby stipulate to change the time of the case management conference
4 scheduled for April 20, 2012 (the “Case Management Conference”) for the following reasons:

5 **A. Reasons for the Change of Time**

6 Plaintiff’s lead trial counsel will be unavailable on April 20, 2012, the date that the Case
7 Management Conference is currently scheduled for. (Order Granting in Part Stipulated Request
8 for Order Changing Time for Settlement Conference before Judge Nandor J. Vadas and for Order
9 Continuing Case Management Conference Scheduled for March 2, 2012, Feb. 15, 2012, Dkt. No.
10 110.)

11 In addition, the parties believe that a later Case Management Conference after the
12 settlement conference scheduled for May 10, 2012 before Magistrate Judge Nandor J. Vadas (the
13 “Settlement Conference”) serves the interests of judicial and party efficiency. (Notice and Order
14 Setting Settlement Conference in Pro Se Prisoner Early Settlement Program, March 9, 2012, Dkt.
15 No. 111.)

16 **B. Previous Time Modifications**

17 The Court has previously granted Defendants three extensions of time to file a dispositive
18 motion. (Order Denying Mot. Appoint Counsel & Default, Oct. 20, 2009, Dkt. No. 12; Order
19 Granting Defs.’ 2nd EOT, Nov. 2, 2009, Dkt. No. 17; Order Granting Defs.’ 3rd EOT, Jan. 8,
20 2010, Dkt. No. 27.)

21 The Court has also granted the Parties’ previous stipulated request to continue the
22 Settlement Conference and the Case Management Conference. (Order Granting in Part Stipulated
23 Request for Order Changing Time for Settlement Conference before Judge Nandor J. Vadas and
24 for Order Continuing Case Management Conference Scheduled for March 2, 2012, Feb. 15,
25 2012, Dkt. No. 110; Notice and Order Setting Settlement Conference in Pro Se Prisoner Early
26 Settlement Program, March 9, 2012, Dkt. No. 111.)

27 **C. Effect the Requested Time Modification Will Have on Schedule**

28 The Parties respectfully request the Court to reschedule the aforementioned Case

1 Management Conference at the Court's earliest convenience following the parties' May 10
2 Settlement Conference. The Parties do not believe that the requested time modification will
3 affect the trial schedule.

4 **D. Proposed Dates**

5 Per the Court's request, the Parties respectfully propose that the Case Management
6 Conference be rescheduled to either Friday, June 8 or Friday, June 15.


