23 California.

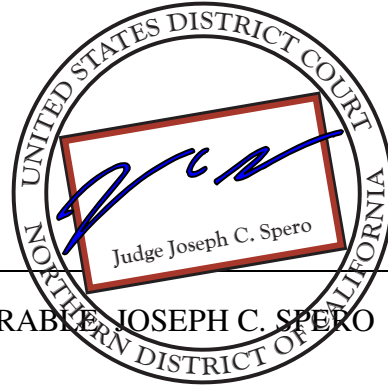
