1 Plaintiffs Richard and Rochelle Doble (“Plaintiffs”) and Defendant The MEGA Life and
2 Health Insurance Company (“Defendant”), by and through their undersigned counsel, hereby
3 stipulate and agree as follows:

4 WHEREAS, the complaint in the above matter was filed on April 11, 2009;

5 WHEREAS, Defendant sought leave to amend its answer to include counterclaim for
6 rescission of contract and fraud, and was granted leave to so amend its answer following hearing
7 before the Court on April 28, 2010;

9 to continue the trial date to accommodate the need for additional discovery, and such discovery
