8           (1) The Stipulation is approved,

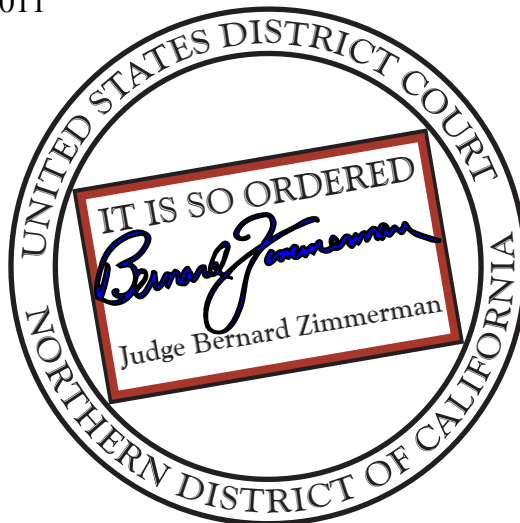
9           (2) Manasian & Rougeau is hereby deemed to have withdrawn from the representation of
