STIPULATION

1
2 Plaintiff SEBASTIAN DEFRANCESCO and Defendants SRI OLD
3 TOWN, LLC, FEDERAL REALTY INVESTMENT TRUST, and TOWN OF
4 LOS GATOS, hereby jointly stipulate and request as follows:

5 The parties previously filed a Consent Decree and Order as to injunctive
6 relief in this case. The Court approved and entered the Order on July 12, 2010.
7 The parties also previously reached a settlement agreement as to damages. The
8 damages payments by all defendants have been received by plaintiff.

9 Currently the parties are negotiating the issue of the amount of plaintiff's
10 attorney fees, litigation expenses and costs to be paid by defendants. These
11 negotiations are proceeding cooperatively.

12 Accordingly, the parties agree and stipulate that continuing the Case
13 Management Conference currently set for July 14, 2010 will promote a more
14 efficient resolution of the case, keeping fees and costs down for both sides, and
15 hereby request that the Case Management Conference be reset to a convenient
16 date on the Court's calendar during October, 2010.
