1 Plaintiffs’ and Plaintiff-Intervenor’s motion *in limine* to exclude the expert reports, opinions,

3 on for hearing before the above-entitled Court on December 16, 2009. After full consideration of all  
4 moving and opposing documents, the court’s record and file in this matter, and the arguments of  
5 counsel, and good cause appearing, **IT IS HEREBY ORDERED:**

6 (1) Plaintiffs’ and Plaintiff-Intervenor’s Motion is hereby GRANTED in its entirety;

7 (2) The expert reports of Dr. Katherine Young, Dr. Loren Marks, and David Blankenhorn  
8 are EXCLUDED from evidence;

9 (3) Dr. Katherine Young, Dr. Loren Marks, and David Blankenhorn are PROHIBITED  
10 from offering expert testimony or opinion in the above-captioned matter;

11 (4) Defendants, Defendant-Intervenors, and their counsel, are PROHIBITED from  
12 introducing or referring in any way to the excluded expert reports, testimony, and/or opinions of Dr.  
13 Katherine Young, Dr. Loren Marks, and David Blankenhorn during trial.
