Petitioner, a state prisoner incarcerated at the Correctional Training Facility in Soledad, has filed a pro se petition for a writ of habeas corpus under 28 U.S.C. § 2254 challenging the California Board of Parole Hearings' ("BPH") October 4, 2007 decision to deny him parole.

**BACKGROUND**

On October 29, 1993, petitioner was convicted of second degree murder with use of a firearm in Los Angeles County Superior Court and, on November 18, 1993, was sentenced to 20 years to life in state prison.

Petitioner has been found not suitable for parole each time he has appeared before the BPH. On May 21, 2009, the Supreme Court of California denied review of his challenge to the BPH's October 4, 2007 decision.

1 **DISCUSSION**

2 A. Standard of Review

3 This court may entertain a petition for a writ of habeas corpus "in behalf  
4 of a person in custody pursuant to the judgment of a State court only on the  
5 ground that he is in custody in violation of the Constitution or laws or treaties of  
6 the United States." 28 U.S.C. § 2254(a).

7 It shall "award the writ or issue an order directing the respondent to show  
8 cause why the writ should not be granted, unless it appears from the application  
9 that the applicant or person detained is not entitled thereto." Id. § 2243.

10 B. Legal Claims

11 Petitioner seeks federal habeas corpus relief from the BPH's October 4,  
12 2007 decision finding him not suitable for parole on the ground that the decision  
13 does not comport with due process. Petitioner specifically claims that the  
14 decision is not supported by some evidence demonstrating that he poses a current  
15 unreasonable threat to the public and is based solely on the unchanging facts of  
16 the crime. Liberally construed, petitioner's claim appears colorable under § 2254  
17 and merits an answer from respondent. See Sass v. Cal. Bd. of Prison Terms, 461  
18 F.3d 1123, 1127-29 (9th Cir. 2006) (finding that refusal to set parole date for  
19 prisoner with 15-to-life sentence implicated prisoner's liberty interest in release  
20 on parole which cannot be denied without adequate procedural due process  
21 protections). Biggs v. Terhune, 334 F.3d 910, 914-15 (9th Cir. 2003) (same).

22 **CONCLUSION**

23 For the foregoing reasons and for good cause shown,

24 1. The clerk shall serve by certified mail a copy of this order and the  
25 petition and all attachments thereto on respondent and respondent's attorney, the  
26 Attorney General of the State of California. The clerk also shall serve a copy of  
27

1 this order on petitioner.

2 2. Respondent shall file with the court and serve on petitioner, within  
3 60 days of the issuance of this order, an answer conforming in all respects to Rule  
4 5 of the Rules Governing Section 2254 Cases, showing cause why a writ of  
5 habeas corpus should not be issued. Respondent shall file with the answer and  
6 serve on petitioner a copy of all portions of the state trial record that have been  
7 transcribed previously and that are relevant to a determination of the issues  
8 presented by the petition.

9 3. If petitioner wishes to respond to the answer, he shall do so by  
10 filing a traverse with the court and serving it on respondent within 30 days of his  
11 receipt of the answer.
